 4. The design must be your own original, unpublished work and must not include any third-party logos or copyrighted material. By entering the competition, you agree that your submission is your own work and it has not been entered in any other contests in the past.

4. All winners will meet and paint with Leon Rainbow, Trenton-based graffiti artist who has been featured on CNN, NY Times and in Princeton Magazine.
5. All winners will be included in any media placement following the contest, with signed permission from a parent/guardian if entrant is under the age of 18.
